The event is the subject of a formal road closure application that has been submitted to Blackpool Council. The conditions of entry have been drawn up in accordance with guidelines set down by Blackpool Borough Council and the Health & Safety Executive as well as other statutory bodies. It is your full responsibility to adhere to all guidelines at all times and a full risk assessment will be carried out by the Pride Events Team prior to the commencement of the parade.

1. There is a legal contract signed between your organisation and Blackpool Pride 2010 and this must be adhered to at all times.
2. All participants and vehicles must be covered by public liability insurance as this will cover your party and your vehicle. The event organisers and their insurers are not liable for any damage to persons or property resulting from the parade.
3. All vehicles and participants should arrive at St Chads Headland (parade starting point) No later than 10.30am. Here you will be met by a member of the Pride Events Team and they will check all necessary documentation with each entrant. Check in time is between 9.30am and 10.30am on the morning of the event, any person or float arriving later than 10.30am could be refused admission into the parade.
4. All vehicles or modes of transport used in the parade must be fully road worthy and lawfully licensed, taxed and tested.
5. All participants and floats must ensure that any fixtures to the vehicle are safe and secure and all reasonable steps have been taken to prevent people falling off vehicles or injury themselves, this will also prevent any damage to the public, staff or property.
6. Entrants can decorate their vehicle as they wish, however there are some Health & Safety restrictions which need to be adhered to:
 - No float or person can contain any inappropriate conduct or content that is likely to offend, this includes on and off the float.
 - Your float must have a maximum height of 16ft. Any float above this will be disqualified as it will be in breach of Health & Safety legislation.
 - No items should be thrown at the crowd, however the handing out of literature and items as the parade moves along is acceptable
 - It is possible some individuals will be demonstrating along the parade. The Local Constabulary have stressed that these individuals must NOT be challenged in any way but reported immediately to a steward or Police Officer.
7. All entries will be inspected by the Pride Events Team in consultation with the Local Constabulary and any entry that is deemed as unsafe, inappropriate, too high etc can be removed from the parade. However a written explanation would be provided at the time of disqualification. No refund will be given in these circumstances.
8. All participants must stay with the Parade until it terminates at Cocker Square. A member of the Pride Events Team will be there to check all entrants who have participated in the parade are all there.
